WHY PLAN?

The question frequently comes up: WHY SHOULD I HAVE A WILL OR DO ESTATE PLANNING?

- 1. Appoint a family member or friend to make medical and life-support decisions for you if you become incapacitated
- 2. Appoint an agent to handle financial decisions
- 3. Designate a Conservator to handle your personal and financial decisions if you become incapacitated (or would you like a court to name someone you might not even want in your home to handle your money?)
- 4. Name a person to handle matters upon your death (an Executor in a Will or Trustee of a Trust)
- 5. Specify gifts to be made upon your death and the distribution of your estate
- 6. Name a Guardian of your choice to raise children under 18 years of age (Don't you want to pick who raises your kids?)
- 7. Provide for distribution to beneficiaries later than at 18 (after college graduation; at 25 or 30, or over several years)
- 8. Avoid or minimize Estate Taxes (or do you want to contribute to paying off the National Debt?)
- 9. Eliminate 1 to 1-1/2 years of court proceedings and thousands of dollars of fees
- 10. Avoid income taxes on appreciated assets (if your home or stocks have gone up in value planning can provide for a tax-free sale by the survivor)
- 11. Plan for spouses and children from multiple marriages (a lack of planning could pit children from prior marriages against the present spouse)
